Terms and conditions:

- a) Consumables are to be brought by incubatee / user or will be charged on case to case basis as per the rate fixed by ICAR-NIVEDI, if agreed mutually.
- b) Other laboratory / workshop/analytical facilities will be charged on case to case basis and as per the charges fixed by the ICAR-NIVEDI
- c) **The rate quoted above is exclusive of taxes. The tax will be charged as per rule.**
- d) Rentals can be paid through payment gateway /DD in favour of ICAR unit NIVEDI, Bengaluru

- e) Rental should be paid in advance or latest by 7th of the starting month, after which interest @2.5% will be levied per day.
- f) Operational or any other charges to be paid as per the norms.
- g) Fine to be levied towards any damage caused by the incubatee / user to ICAR-NIVEDI properties as decided by the Competent Authority of the Institute.
- h) Normal health and safety standards are to be observed and maintained within the premises of NIVEDI, as prescribed by the In-charge, Bio-safety Officer of the Institute. No hazardous material can be brought inside the premises without prior approval of the authorities.
- i) The officers of this Institute shall be allowed access to visit and inspect the office space, any other facilities rented out to incubatee / user as and when required.
- j) No legal, financial or criminal liability shall arise for commission of any act or omission thereof in respect of any accident or injury to any workman or any other person employed and ICAR-NIVEDI stands indemnified against any claims, damages or proceedings of any manner.
- k) The mentorship/guidance of scientific, technical, or commercial nature shall be chargeable if availed. No services shall be rendered without the applicable fees either pre-assigned or fixed on case to case basis. The Director, ICAR-NIVEDI is the final authority to fix or re-assign the fee for various services available.
- l) Notwithstanding any issue pending between the incubatee / user and the Institute, the incubatee / user shall have to vacate the premises on the notice of vacation or completion of the agreed term of incubation.
- m) The incubatee /user shall have to follow all the rules and/or guidelines prescribed and/or modified from time to time by the Institute. For any unprecedented issues, the available rules of NIVEDI shall be applicable and the Director shall have full authority to form/amend all/any of the guidelines/rules.
- n) Foreign Visitors: Incubatee /user shall be required to inform and take permission from the Institute about any visitors from abroad, foreign collaboration and/ or foreign partner and shall abide by the rules/procedures of ICAR / DARE GoI.
- o) No material shall be allowed to be taken out of the premises of the ICAR-NIVEDI without prior written permission of the authorities.
- p) In case of any disagreement on rules and guidelines, the matter may be referred to the Director, ICAR-NIVEDI. Decision of the Director will be final and abiding
